### Learning Agreement Terms and Conditions

- I agree to abide by the terms of the College's values, standards and policies as explained to me during the College Preparation Day/Enrolment Days.
- Good conduct, a willingness to learn and self-motivation are an important part of A Level study which prepares students for Higher Education. I understand that St. Bede's Catholic College reserves the right to withdraw my place if I am not abiding by these principles.
- I am committed to completing the full qualification(s) for which I have enrolled, and understand that this requires me to be registered with the appropriate awarding body. I may be liable to pay the cost of any examination fees paid by the College on my behalf should I be absent for any reason other than ill health.
- I will advise the College if I enroll at another Post-16 provider (e.g. College, School, Sixth Form etc).
- I accept that if my total attendance in Year 12 is less than 95% up to and including 1<sup>st</sup> May, I will not automatically be allowed to return for the second year of the course or for further full-time courses in the next academic year. My financial assistance will also be withdrawn if my attendance falls below 95%.
- I accept that if my total attendance in Year 13 is less than 95% up to and including 1<sup>st</sup> March, I will not automatically be entered for external examinations and my place may be withdrawn.
- I accept that my attendance to collaborative subjects, such as Drama A Level, will affect other students within the group and that I may be withdrawn from this subject if my attendance falls below 95%.
- I understand that if I receive financial help to assist with the purchase of course materials, I will be liable to pay this back to the College if I withdraw from my programme of study, or if I substantially reduce my programme hours.
- I understand that if I receive any financial support through the 16-19 Bursary Fund, I will be liable to pay this back to the College if I withdraw from my programme of study.
- I understand that it is College policy that staff may contact the parents/carers of students to discuss academic progress, attendance and conduct during my time of study at St Bede's Catholic College, 6<sup>th</sup> Form.
- I understand that I cannot work more than 12 hours a week in external employment.
