## Allocation of Places to St Bede's Catholic College September 2022

As St. Bede's Catholic College is over-subscribed, the criteria published in the Governors' Admissions Policy has been applied to allocate the 207 places that are available.

All applications received by Governors and the Local Authority by the published deadline of 31<sup>st</sup> October 2021, falling into Priorities 2, 3, 4, 5, 7 and 8 have been offered places. There were no applications that fell into Priorities 1 or 6. 6 places have been offered to an applicant in Priority 9.

In total, 206 places have been offered. 1 place is being held as requested by Bristol City Council for SEND applications.

3 applicants in Priority 9 and all applicants in Priorities 10 and 11 unfortunately have not been successful at this stage in securing a place with us for September 2022.

The college is happy to receive calls from families who have been unsuccessful in this round if they wish to know the priority in which their application has been placed. It may be possible to make further offers if any family decides not to accept the place allocated to their child. Following first round offers, if requested, we will be in a position to give some indication of the likelihood of success with second round offers.

On the reverse of this letter you will find information on how to appeal the decision of the Governing Body.
