	A "letter of entitlement" from JobCentre Plus								
	A letter from the National Asylum Support Service (NASS) or a Certificate of Benefits								
	A copy of your form TC602 – Inland Revenue Tax Credit Award Notice								
	A copy of your 'Pension Credit M1000 Award Notice'								
	Working Tax Credit run-on (paid for the four weeks after you stop qualifying for Working Tax Credit)								
	Child Tax Credit (with no Working Tax Credit) with an annual income of no more that £16,190
